# 2.0 SUSTAINABLE DEVELOPMENT GOALS (SDG)

# 2.1 SDG 1: No Poverty

The University will make sure that everyone, including staff and students, especially those who are less fortunate, have the same rights to money and resources. They will also have access to basic services, technology, and banking services through programmes and policies offered by the University.

# 2.2 SDG 2: Zero Hunger

The University will eradicate hunger and make sure that everyone at the University, especially those who are underprivileged, has access to safe, nutritious, and sufficient food. It will also help with sustainable agriculture and food production through research, partnerships, and programmes.

# 2.3 SDG 3: Good Health and Well-Being

The University will make sure that everyone at the University, including both men and women, has access to information, education, and healthcare services to maintain good health. This includes access to preventive measures and treatments. The University will also provide sport facilities to promote a healthy lifestyle and well-being, including mental health.

# 2.4 SDG 4: Quality Education

The University will make sure that all students, including those who study online or remotely, can get educational resources and support. It includes learning about sustainable lifestyles, human rights, equal treatment for all, promoting peace and non-violence, being global citizens, and understanding and respecting different cultures and how they contribute to sustainable development.

# 2.5 SDG 5: Gender Equality

The University promises to stop any unfair gender-biased treatment and make sure that both men and women, including staff and students, can fully take part and have the same chances to be leaders in all levels of decision-making.

#### 2.6 SDG 6: Clean Water and Sanitation

It will also work to protect and restore places like hills, forests, wetlands, rivers, and lakes that are connected to water. This will involve working with local and international partners and helping local communities get involved in managing water and sanitation. The University will also promote water reuse and recycling to benefit everyone.

# 2.7 SDG 7: Affordable and Clean Energy

This includes things like renewable energy, using energy more efficiently, and developing cleaner methods to use fossil fuels. The University will support new ideas and increase the amount of money spent on research and development, both by the government and private companies. This will help everyone in the University move towards sustainable development.

# 2.10 SDG 10: Reduce Inequalities

The University promises to help everyone feel included and make sure everyone has a fair chance, regardless of their age, gender, disability, race, origin, religion, financial status, or other factors. This means eliminating of unfair laws, rules, and actions, and making new ones that are fair.

# 2.11 SDG 11: Sustainable Cities and Communities

The University promises to make sure everyone, especially women, children, the elderly, and those with disabilities, can easily use safe and welcoming outdoor areas. It will also facilitate movement around the campus in an environmentally friendly manner. The University will try harder to take care of and protect its cultural and natural history.

#### 2.12 SDG 12: Responsible Consumption and Production

#### 2.13 SDG 13: Climate Action

# 3.0 MANUAL FOR ORGANISING PROGRAMMES AND ACTIVITIES BASED ON SUSTAINABLE DEVELOPMENT GOALS (SDG)

#### 3.1 Introduction

The manual advises the University to:

- i. Map SDGs with activities/programmes that are currently/previously implemented at the university.
- ii. Develop internal capacity and commitment towards SDGs.
- iii. Identify priorities, opportunities, and gaps.
- iv. Integrate and implement SDGs through the university's strategies, policies, and planning.

# 3.2 Objective

The objectives of this manual are to:

- i. Increase awareness among university residents about the SDGs.
- ii. Enhance the visibility of university activities related to the SDGs.
- iii. Contribute to efforts in fostering social, economic, and environmental sustainability.
- iv. Assist in the collection of data and information for participation in the Times Higher Education (THE) Global Impact Ranking.
- v. Establish internal controls over the use of logos and icons.
- vi. Monitor and evaluate the performance of SDGs and disseminate information on actions taken related to SDGs achievements to the university community and external parties.
- vii. For teaching and learning, instructors are requested to identify SDGs elements and emphasize them in their classes to raise students' awareness about the SDGs.

#### 3.3 Procedure and Guidelines

Mapping SDGs with Activities/Programmes:

- Identify the Sustainable Development Goals (SDGs) related to university activities or programmes.
- ii. Conduct a detailed analysis to determine the potential contributions of these activities or programmes to the selected SDGs.

# 3.4 Use of SDG Logo for Activities/Programmes:

- i. Adhere to the established guidelines and regulations for using the SDGs logo.
- ii. Include a brief yet clear explanation of how the activity or programme is related to the selected SDGs.

#### 3.5 Procedure and Guidelines

Mapping SDGs with Organised Activities:

- i. Any proposal submitted to the University Committee for approval that involves financial allocation must specify the related SDGs along with a brief justification.
- ii. Any proposal submitted to Faculty/Department Management for approval that involves financial allocation must specify the related SDGs along with a brief justification.
- **iii.** The brief justification must include an explanation of how the proposed activity aligns with the SDG goals.

# 3.6 The use of SDGs logo and icons in university-sponsored posters and activities.

- The use of SDGs logo and icons is based on the guidelines provided by the Sustainable Development Goals United Nations Department of Global Communications.
- All promotional posters for activities/programmes at PTj and university level must include logos, icons, and hashtags related to the Sustainable Development Goals (SDGs).
- iii. In official activity posters, the use of the Sustainable Development Goals (SDG) logos and icons must be accompanied by the university's official logo and appropriate explanations. This will demonstrate the connection between the activity, the SDGs, and the university.

# 3.7 The responsibilities of the Head of Responsibility Centre (PTj) regarding the mapping and use of SDGs logos and icons

- I. Mapping Activities with SDGs:
  - The Head of PTj must ensure that PTj activities are relevant to the corresponding SDGs.
  - Records of activities mapped to SDGs must be kept for reporting purposes to the Publication and Rating Division (PRD)/Corporate Communication Centre (PKK) or other relevant PTj.
- II. Activity Reporting in PTj Annual Reports:
  - It is recommended that activity reports related to SDGs be included in the PTj's annual report as records.
- III. Visibility of UMK Commitment to SDGs:
  - Activities and posters containing SDG logos/icons should be promoted on PTj or UMK's official social media platforms to enhance aware ness of the university's efforts in achieving Sustainable Development Goals.
